QUESTIONNAIRE

EMPLOYEE, VOLUNTEER OR CONTRACTOR BEING CONSIDERED FOR A POSITION WITH LIVERMORE AREA RECREATION AND PARK DISTRICT

Section 5164 of the Public Resources Code of the State of California prohibits Livermore Area Recreation and Park District from hiring a person for employment, hiring a volunteer, or contracting with any person to perform services at any parks, playgrounds or recreational centers used for recreational purposes in a position having supervisory or disciplinary authority over any minor, if the person has been convicted of certain crimes under the California Penal Code. Section 5164 also authorizes Livermore Area Recreation and Park District to screen any such prospective employee, volunteer or contractor for his or her criminal background.
